- a. Policy Committee began investigating grievance procedure policies in place at Emory and found that working groups under Kris West, the Chief Compliance Officer, were doing similar work, so they discussed combining efforts.

  - Q: It is often hard for faculty researchers to find answers to their questions, and it takes significant time. They often need to look to the online resources of other institutions.
    - A: The Faculty Advisory Board will help field such questions.
  - ii. Q: What will the aforementioned dashboards accomplish? Allow units to look at their own progress? Is it for VP's office to compare programs?
    - A: Metrics will not be imposed university-wide. They will be tailored to different units. They will inform the answers to: How does each unit compare itself to peer institutions?
  - iii. Q: Why are response letters shared with faculty, chairs, and deans?
    - A: For root cause analysis, it would have gone through all these levels. This would only happen for significant concerns or events.
  - iv. Q: What is out there in terms of innovative metrics?
    A: It varies by discipline. The question for the VP is how to put this together, especially interfacing between disciplines.
    Innovation is hard to define, but we want to set up a framework for innovation. Deans are focused more at the level of the individual school. VP is interested in university-wide approaches—One Emory.
  - v. Q: Is any of this coming from a third party? How are the terms being generated?

A: The metrics and dashboards would be coming from the heads of units at individual schools.
